RESOLUTION NO. 05-2011

WHEREAS, the electors of the Town of Kildare, Juneau County, Wisconsin, adopted village powers at an annual town meeting of the electors on April 2, 1962; and

WHEREAS, the Town Board of the Town of Kildare, acting within the village powers granted by the electors has the authority to establish certain fees under s. 61,34 Wis Stats; and

WHEREAS, The Town Board of the town of Kildare has determined a need for a change in building inspection fees to cover building inspections and administrative costs;

NOW THEREFORE LET IT BE RESOLVED that the Town Board of the Town of Kildare, Juneau County Wisconsin, hereby establishes the following building permit and land use fees effective July 31, 2011:


1 or 2 Family Dwelling	\$.15 per sq. ft.
Modular on Basement	\$.15 per sq. ft.


