 - e. The Trash and Recycling cost, \$106,923.20 were reviewed and the total number of parcels assess with improvements or issued a camper permits is 533 parcels. Cost per parcel will be \$200.60 if not paid by due date it will be added as a special charge on your 2025 tax bill.
 - f. The 2026 Annual Town Meeting is hereby scheduled for 7:00 PM on April 9, 2026 immediately preceding by the Regular Town Board Meeting.



Licenses

The town issued alcohol licenses to five businesses thru June 30, 2025. Two Class "A" combination Beer & Alcohol license (for "off-site" consumption only) was issued to D.J. Kojo's Kampin' and Shorty's Krazy Korner; two Class "B" combination Beer & Alcohol license (for "off or on" site consumption) were issued to Famous Garage Bar and Ho-Chunk RV Resort and Campground; one Class B Beer Only licenses (for "off or on" site consumption) was issued to Yukon Trails Camping; there were 9 Operators (Bartender) Licenses. The town also issued Shorty's Krazy Korner one Cigarette & Tobacco license. Kildare also licensed six campgrounds: DJ Kojo's Kampin', Ho-Chunk RV Resort & Campground, Yukon Trails Camping, Lemonweir Campsites, Famous Garage Bar and Glamping Bros LLC.

Budget and Tax Levy

The 2024 Town Budget of \$528,595 was adopted on November 13, 2023. Kildare's town levy for 2024 (payable in 2025) was approved at \$161,356.

Buildings and Permits

During 2024 permits were issued for 10 Fire Signs, 1 Mobile Homes, 3 Homes, 4 Garages, 2 Driveways, 3 Car Ports, 0 Additions, 10 Outbuildings/Sheds/Pole Barns, 3 Deck/Porch, 0 Occasional-Use Cabins, 7 Campers and 1 Line work.

Population

The State of Wisconsin Department of Administration's final estimate of the town's 2024 "full-time" population continues to be 704.

Property Values & Taxes

The Town's total valuation increased from \$114,595,500 to \$116,593,100. Property taxes levied - including Juneau County, Mauston Schools, WI Tech Colleges and Kildare - totaled \$1,860,654.28, an increase of \$77,003.74.

Recycling

The DNR's annual requirements for recycling curbside pickup are 82.40 lbs per capita collection, we are well above this at 172.98 lbs per capita collected an increase of 86.39 lbs per capita collected. Last year we had a total of 30.22 tons and this year we are up to 60.89 tons, lets continue recycling and spreading the word to keep diverting unnecessary waste to the landfills.
